ORDINANCE NO. SP-1098, S-2002

AN ORDINANCE GRANTING FINANCIAL ASSISTANCE IN THE AMOUNT OF ONE HUNDRED FIFTY THOUSAND PESOS (P150,000.00) TO THE FAMILY OF THE LATE HONORABLE ROBERTO A. MIGUEL, FORMER CITY COUNCILOR REPRESENTING THE LEAGUE OF BARANGAYS, WHO DIED ON JULY 31, 2000.

WHEREAS, a gentleman of the highest order who was one of the clearest voice to ever articulate the institutional concerns of the Barangay organization in the august balls of the Quezon City Council has just passed away;

WHEREAS, the Honorable Roberto A. Miguel, former President, Liga ng mga Barangay in Quezon City and member, as Sectoral Representative, of the City Council from 1989 to 1994 gave himself selflessly to public service, leaving a performance record worthy of emulation by those who wish to enter public service;

WHEREAS, with the demise of Councilor Miguel, the City which he served faithfully and well has the chance to express its appreciation to him in the form of a financial assistance for his heirs and dependents.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The amount of One Hundred Fifty Thousand Pesos (P150,000.00) is hereby appropriated from any available fund in the City Treasury as financial assistance to the heirs of the late Hon. Roberto A. Miguel, former City Councilor as Sectoral Representative representing the Liga ng mga Barangay, 1989-1994.
