ORDINANCE NO. SP- **1101**, S-2002

AN ORDINANCE DECLARING THE INDEPENDENCE OF LAGRO HIGH SCHOOL PAYATAS ANNEX, LOCATED AT BARANGAY PAYATAS, QUEZON CITY FROM ITS MOTHER UNIT.

Introduced by Councilors VOLTAIRE GODOFREDO L. LIBAN, III, AIKO M. YLLANA, RAMON P. MEDALLA, ALLAN BUTCH T. FRANCISCO, ERIC Z. MEDINA, MARY ANN L. SUSANO and RESTITUTO B. MALAÑGEN.

WHEREAS, Sec. 13 of R.A. 7160, otherwise known as the Local Government Code of 1991, authorizes the Sangguniang Panlungsod of highly urbanized cities in consultation with the National Historical Institute to change the name of public elementary, secondary and vocational or technical schools, community colleges and non-chartered colleges;

WHEREAS, the Lagro High School, Payatas Annex, located in Barangay Payatas, Quezon City, has a school population of 2,185 which increases every school year, a total of 62 permanent and contractual teachers, school buildings, equipment, materials and other facilities necessary for said school to operate and function by itself and independently from its mother unit;

WHEREAS, said school serves the secondary school needs of Barangay Payatas, Quezon City, and its surrounding areas;

WHEREAS, the Sangguniang Barangay of Payatas, Quezon City, under its Resolution No. 53, S-98, has requested the Department of Education, Culture and Sports to separate and segregate the Payatas Annex of Lagro High School from its mother unit;

WHEREAS, it is more advantageous and beneficial to both teachers and students that said Payatas Annex of Lagro High School be granted autonomy and independence in the management of its own school affairs.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The Payatas Annex of the Lagro High School, located in Barangay Payatas, Quezon City is hereby separated, segregated and declared independent from its mother unit, the Lagro High School proper.


SECTION 2. Said high school is hereby renamed and henceforth it shall be called and referred to as the Payatas High School.


SECTION 3. All the teachers and other employees, land, school buildings, equipment and facilities, materials and supplies, and all other resources presently used by Lagro High School, Payatas, Annex, including all rights and obligations, are hereby transferred to, and shall be retained by said Payatas High School.

SECTION 4. This Ordinance shall take effect immediately upon its approval.
