ORDINANCE NO. SP-1 107

AN ORDINANCE PROVIDING FOR THE CREATION OF BARANGAY SANGANDAAN HEALTH CENTER LOCATED AT BARANGAY SANGANDAAN, QUEZON CITY, AS SEPARATE AND INDEPENDENT FROM THE BANLAT HEALTH CENTER, AND CREATING CERTAIN POSITIONS THEREIN.

WHEREAS, it is enshrined in the Local Government Code of 1991 that local government units shall provide basic health service facilities and are tasked by law to establish and meintain such services and facilities in its jurisdiction;

WHEREAS, Barangay Sangandaan Health Station is still a satellite station of Banlat Health Center, Barangay Tandang Sora, Quezon City;

WHEREAS, the Barangay Council of Barangay Sangandaan has adopted Resolution No. 41, S-98, urging the Honorable Mayor and the Sangguniang Panlungsod of Quezon City to approve the conversion of Barangay Sangandaan Satellite Health Station into a permanent Barangay Health Center and to provide funds for a complete medical staff, equipment and supplies;

WHEREAS, the establishment of a permanent health center complete with all amenities and personnel will make more efficient the delivery of basic health services which will redound to the benefit of the residents of Barangay Sangandaan;

WHEREAS, the setting up of an independent health center will allow the Sangguniang Barangay of Sangandaan in coordination with the City Health Office to help plan, improve and expand the delivery of health services to the community;

WHEREAS, it is now deemed appropriate, proper and timely for the Sangandaan Satellite Health Station to be a full and complete health center separate and distinct from the Banlat Health Center, Barangay Tandang Sora.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. There is hereby created a Health Center at Barangay Sangandaan, Quezon City to be known as the SANGANDAAN HEALTH CENTER, which shall be independent and separate from the Banist Health Center located at Barangay Tandang Sora.

SECTION 2. The following positions in said Barangay Sangandsan Health Center are hereby created with their corresponding salary grades:

SECTION 3. This ordinance shall take effect upon its approval.
