ORDINANCE NO. SP 1108, S-2001

AN ORDINANCE AUTHORIZING BARANGAY DIOQUINO ZOBEL TO UTILIZE A PART OF THE DEAD-END PORTION OF LIZARDO STREET AS SITE FOR A STORAGE ROOM OF BARANGAY EQUIPMENT AND OTHER BARANGAY PROPERTIES, TO BE CONSTRUCTED OUT OF BARANGAY FUNDS.

WHEREAS, Barangay Dioquiño Zobel is only utilizing a small area for its barangay hall and is in need of a safe place to store various equipment for clean and green, cleanliness and beautification and other projects;

WHEREAS, the barangay council, through Barangay Resolution No. 20, S-2001, is requesting the City government for authority to utilize the dead-end portion of Lizardo Street for a site of a barangay storage room to be constructed from an approved barangay fund;

WHEREAS, the barangay council has made an assurance that the proposed storage room will neither obstruct traffic nor inconvenience any resident in the vicinity and that the nearest neighbor, Mr. Willie Villarosa, has written the barangay chairman to make an assurance that "we are in full support of your worthy project," referring to the storage room.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The Barangay Council of Barangay Dioquiño Zobel is hereby authorized to utilize a part of the dead-end portion of Lizardo Street for a barangay storage room.






