## ORDINANCE NO. SP- 1120 S-2002

**ORDINANCE** APPROVING SUBDIVISION ANTHE PLAN CENTENNIAL VILLAGE WITH TWO HUNDRED SIXTY-ONE (261) SALEABLE LOTS (150 LOTS FOR THE MAIN PROJECT AND 111 LOTS FOR SOCIALIZED HOUSING), AS APPLIED FOR BY JCR HOLDINGS CORP., WITH BUSINESS ADDRESS AT UNIT 7 2/F FRANCISCO GOLD CONDOMINIUM I, EDSA, QUEZON CITY, CONTAINING AN AREA OF THIRTY THREE THOUSAND THREE HUNDRED SIXTY-FOUR (33,364) SQUARE METERS, COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED N-145191, N-145192, AND N-145186 ISSUED BY THE REGISTER OF DEEDS OF QUEZON CITY, IN THE NAME OF MANUEL L. QUERUBIN LOCATED AT BARANGAY PAYATAS, QUEZON CITY, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-92 AND P.D. 957.
