ORDINANCE NO. SP. 1124, S-2002

AN ORDINANCE AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR. TO CONSTRUCT STRUCTURES TO BE UTILIZED AS RESTAURANT OR CANTEEN WITHIN THE CITY HALL COMPLEX TO BE LEASED TO PROSPECTIVE OPERATORS.

WHEREAS, it has been noted and of public knowledge about the absence of canteens, and restaurants operating within the City Hall Complex,

WHEREAS, employees and patrons of the City government and the Justice Hall have to go out of the City Hall vicinity to lunch or look for food considering that the only restaurant existing is the cuisine whose prices of food are expensive and the area cannot accommodate the number of customers;

WHEREAS, the establishment of said canteen or restaurant will create livelihood for the private sector and likewise an income generating venture for the City government pursuant to its proprietary function.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The City Mayor is hereby authorized to provide a space and construct structures within the City Hall Compound to be utilized as restaurant canteen and for other business purpose.

SECTION 2. Said structure shall be open for lease to the private sector and/or to government employees who are able, capable and willing to operate a restaurant, canteen and other business purposes.

SECTION 3. The lease contract entered into by the City government shall be subject to the authority or ratification by the City Council.

SECTION 4. The City Engineering Office, The Business Permits and Licensing Office, the City Health Department and the City Planning and Development Office through the Office of the City Mayor shall take charge in the implementation of this Ordinance.


SECTION 5. The funds needed for this purpose shall be taken from the general funds of the City as certified available by the City Treasurer.
