AN ORDINANCE GRANTING AUTHORITY TO OPERATE
MOTORIZED TRICYCLE FOR HIRE WITHIN THE ROUTE COVERING
ARBORETUM VIA CENTRAL AVENUE, FOREST SIDE, Q.C. VILLE
AND PAEL ESTATE, ALL WITHIN THE TERRITORY OF BARANGAY
CULIAT, QUEZON CITY.

WHEREAS, at present there is no tricycle for hire servicing the
territory of Arboretum, via Central Avenue, Forest Side and Pael Estate;

WHEREAS, the Board of Directors of the Q.C. Ville-Arboretum
Tricycle Operators and Drivers Association, Inc., has applied for Route
Measurement Capacity (RMC) to service the said territory;

WHEREAS, the Q.C. Ville-Arboretum Operators and Drivers
Association Inc. is duly registered with the Securities and Exchange
Commission;

WHEREAS, the application is covered by a Barangay Resolution
adopted by the Sanggunian of Barangay Culiat, as well as the Homeowners
Association covering the territory;

WHEREAS, pursuant to the provision of Section 458 (3) (vi) of the
Local Government Code of 1991 and Ordinance No. SP-15, S-92, enacted
pursuant thereto, mandates the City Council to regulate the operation of
tricycles and grant franchises for the operation thereof within the territorial
jurisdiction of Quezon City.

NOW, THEREFORE.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. There is hereby granted a franchise to operate a motorized tricycle-for-hire for fifty (50) units to the Q.C. Ville Arboretum Tricycle Operators and Drivers Association Inc. within the route:

ARBORETUM via CENTRAL AVENUE
FOREST SIDE, Q.C. VILLE and
FAEL ESTATE and vice-versa

SECTION 2. The individual applicants for franchise should be filed with and approved by the Tricycle Franchising Board upon compliance of existing rules and regulations.

SECTION 3. This Ordinance shall take effect upon its approval.
