ORDINANCE NO. SP-**1133**-S-2002

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED RESIDENTIAL HOUSING PROJECT (BP BLG. 220) WITH SIXTY (60) LOTS: COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF TWO THOUSAND SEVEN HUNDRED SIXTY-FOUR SQUARE METERS AND FIFTY SQUARE DECIMETERS (2,764.50 SQ.M.) COVERED BY TRANSFER CERTIFICATE OF TITLE NO. N-220878 OF THE REGISTRY OF DEEDS OF QUEZON CITY, AND LOCATED AT LOT 86-B-2, PSD-00-054695, SARMIENTO ST., BARANGAY STA. MONICA, NOVALICHES, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE CHRISTIAN-MUSLIM NEIGHBORHOOD HOMEOWNERS ASSOCIATION, INC., PHASE II (CARANDANG PROPERTY), SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of a Socialized Residential Housing Project (BP Blg. 220) with sixty (60) Lots; Community Mortgage Program, containing an area of Two Thousand Seven Hundred Sixty-Four Square Meters and Fifty Square Decimeters (2,764.50 sq.m.), covered by Transfer Certificate of Title Numbered N-220878 of the Registry of Deeds of Quezon City, located at Lot 86-B-2, Psd-00-054695, Sarmiento St., Barangay Sta. Monica, Novaliches, Quezon City, Metro Manila, as applied for by the Christian-Muslim Neighborhood Homeowners Association, Inc. Phase II (Carandang Property), is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No., SP-56, S-93 Batas Pambansa Blg. 220, details of which are as follows:




