## ORDINANCE NO. SP 1135; S-2002

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED RESIDENTIAL HOUSING PROJECT (BP BLG. 220) WITH FIFTEEN (15) LOTS; COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF FIVE HUNDRED SIXTY ONE SQUARE METERS (561 SQ.M.), COVERED BY TRANSFER CERTIFICATE OF TITLE NO. RT-104176 (207147) OF THE REGISTRY OF DEEDS OF QUEZON CITY, LOCATED AT LOT 2, BLOCK 10, PCS-2874, PRESIDENTIAL ST., CORNER, LEGISLATIVE ST., BARANGAY BATASAN HILLS, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE SAMAHAN LAKAS NG BATASAN HOMEOWNERS ASSOCIATION, INC., (SALAKAB), SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP. 56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED

Section 1.
