ORDINANCE NO. SP. 1160 S-2002

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED RESIDENTIAL HOUSING PROJECT (MODEL E - BP BLG. 220) WITH THREE HUNDRED NINETY-TWO (392) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF NINETEEN THOUSAND EIGHTY-HIGHT SQUARE METERS (19,088 sq.m.), COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 35564 OF THE REGISTRY OF DEEDS OF QUEZON CITY, LOCATED AT LOT 871 TALA ESTATE, TAWID SAPA II, PHASE II, BARANGAY KALIGAYAHAN, NOVALICHES, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE SAMAHANG PINAGBUKLOD NG BARANGAY KALIGAYAHAN, INC., (SAPIKA), SUBJECT TO CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. \$P-56, S-92 AND BATAS PAMBANSA BILANG 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

Section 1. The subdivision plan for a Socialized Residential Housing Project (Model E - BP Blg. 220) with Three Hundred Ninety-Two (392) lots, Community Mortgage Program, containing an area of nineteen thousand eighty-eight square meters (19,088 sq.m.), covered by TCT No. 35564 of the Registry of Deeds of Quezon City, located at Lot 871, Tala Estate, Tawid Sapa II, Phase II, Barangay Kaligayahan, Novaliches, Quezon City, Metro Manila, as applied for by the Samahang Pinagbuklod ng Barangay Kaligayahan, Inc., (SAPIKA), is hereby APPROVED, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Bilang 220 and the details of which are hereby quoted below, as follows:
