ORDINANCE NO. SP-**1168**S-2002

AN ORDINANCE REQUIRING ALL CINEMA OWNERS AND OPERATORS IN QUEZON CITY TO INCREASE THE PRICES OF THEIR ADMISSION TICKETS BY ONE PESO (P1.00) COVERING THE PERIOD FROM OCTOBER 1 TO 31, 2002 TO SUPPORT THE PROGRAMS AND ACTIVITIES OF THE BOY SCOUTS OF THE PHILIPPINES, QUEZON CITY CHAPTER.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:






SECTION 3. This Ordinance shall take effect immediately upon its approval.


