ORDINANCE NO. SP 1173, S-2002

AN ORDINANCE APPROVING THE SUM OF ONE MILLION PESOS (P1,000,000.00) FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY FOR THE REPRODUCTION OF THE MONUMENT OR SHRINE OF PRESIDENT MANUEL LUIS QUEZON IN THE QUEZON CITY HALL, TO BE ERECTED WITHIN THE COMPOUND OF NOVALICHES DISTRICT CENTER (NDC), ALSO KNOWN AS THE NOVALICHES MINI CITY HALL.

WHEREAS, as the founder of Quezon City, the monument or shrine of President Manuel Luis Quezon shall be erected not only in Quezon City Hall, but also in other places where the city inhabitants usually converge to remind them of his legacies;

WHEREAS, the Novaliches District Center, also known as the Novaliches Mini City Hall, which was established almost two decades ago, was the house of some historic events featuring Quezon City, hence, an appropriate place for the construction of President Manuel Luis Quezon's monument or shrine.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:


SECTION 1. There is hereby appropriated the sum of One Million Pesos (P1,000,000.00) from any available funds of the City Treasury for the reproduction of the monument or shrine of President Manuel Luis Quezon in Quezon City Hall.



SECTION 3. This ordinance shall take effect immediately upon its approval.


