ORDINANCE NO. SP-1175, S-2002

AN ORDINANCE MANDATING ALL CINEMA OWNERS OPERATING WITHIN THE JURISDICTION OF QUEZON CITY TO GIVE AN ADDITIONAL TEN PERCENT (10%) DISCOUNT ON THE PRICE OF THE TICKET OVER AND ABOVE THE TWENTY PERCENT (20%) DISCOUNT ALREADY BEING GIVEN TO THE SENIOR CITIZENS IN ACCORDANCE WITH THE SENIOR CITIZENS LAW.

WHEREAS, with the present cost of living including the high cost of medicines and medical services, senior citizens have barely enough funds left for simple leisures.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. All cinema owners operating within the territorial jurisdiction of Quezon City are mandated to give an additional ten percent (10%) discount on the price of the ticket, over and above the twenty percent (20%) discount already being given to the Senior Citizens in accordance with the Senior Citizens Law.
