ORDINANCE NO. SP-1175, S-2002

AN ORDINANCE MANDATING ALL CINEMA OWNERS OPERATING WITHIN THE JURISDICTION OF QUEZON CITY TO GIVE AN ADDITIONAL TEN PERCENT (10%) DISCOUNT ON THE PRICE OF THE TICKET OVER AND ABOVE THE TWENTY PERCENT (20%) DISCOUNT ALREADY BEING GIVEN TO THE SENIOR CITIZENS IN ACCORDANCE WITH THE SENIOR CITIZENS LAW.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:



All cinema owners operating within the territorial jurisdiction of Quezon City are mandated to give an additional ten percent (10%) discount on the price of the ticket, over and above the twenty percent (20%) discount already being given to the Senior Citizens in accordance with the Senior Citizens Law.


