ORDINANCE NO. SP-1185, S-2002

AN ORDINANCE AMENDING SECTION 2 OF ORDINANCE NO. NC-86, S-89, SO AS TO INCREASE THE PER DIEM OF MEMBERS OF THE LIQUOR LICENSING AND REGULATORY BOARD, THEREBY ADJUSTING THE RATE FROM THE AMOUNT ALLOCATED TWELVE (12) YEARS AGO IN 1989 TO AN AMOUNT NOW COMMENSURATE TO THE TASK AND THE PRESENT MONETARY VALUATION AND ECONOMIC SITUATION CONSIDERING THAT THEY ARE NOT REGULARLY EMPLOYED AND THEREFORE NOT RECEIVING ANY SALARY.

WHEREAS, under Section 1 of Ordinance No. NC-86, S-89, the Liquor Licensing and Regulatory Board (LLRB) was created under the Office of the City Mayor composed of a Chairman and two (2) Board Members to implement the provisions of City Liquor Ordinance No. NC-85, S-89;

WHEREAS, under Section 2 of the above-cited ordinance, the Board shall meet in regular session twice a week and in special session not more than four times a month and for every meeting thereof, the Chairman shall be entitled to a per diem of Five Hundred Pesos (P500.00) and the two members to a per diem of Four Hundred Pesos (P400.00) each per session considering that they are not regularly employed and not receiving any salary but instead a per diem as stipulated above;

WHEREAS, considering that the amount of the per diem was allocated when the above-cited ordinance was approved in 1989 or twelve years ago, the rate is indeed not anymore commensurate and suited to the task and the present value of money;

WHEREAS, the LLRB is charged to regulate the selling, serving and dispensing of liquor and/or intoxicating beverages, to regulate the establishment and operation of the liquor business in the City so as to lessen criminality, the preservation of peace and order and to upgrade operation standards of business establishments in the manufacturing, production, distilling, selling, serving and dispensing of liquor and/or intoxicating beverages. Further, to prohibit and penalize

intoxicating and other species of disorderly conduct or disturbance of peace and to compel operators of amusement places, eateries and dealers of liquor to properly observe and comply with the requirements of law, ordinances and directives regulating business operations.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:


SECTION 1. The rate of the per diem of the Chairman is adjusted from Five Hundred Pesos (P500.00) to One Thousand Pesos (P1,000.00) and the two (2) Board Members from Four Hundred Pesos (P400.00) to Eight Hundred Pesos (P800.00) each per session.


SECTION 2. The funds needed for the adjustment as stated above will be charged from Item Honorarium and Other Benefits of Personal Services under Current Operating Expenditures of the year 2002 budget of the Liquor Licensing and Regulatory Board.

SECTION 3. The provision of this ordinance shall take effect upon its approval.
