ORDINANCE NO. SP-**1216** S'2002

AN ORDINANCE ESTABLISHING A BRANCH OFFICE OF THE CITY TREASURER'S OFFICE AT AREA 7, DISTRICT II, QUEZON CITY.

WHEREAS, the City Council is empowered to generate revenues for the development plans, program objectives and priorities of the City;

WHEREAS, the growth of population caused by development of subdivisions and migration in Area VII has congested the area with business and commercial establishments;

WHEREAS, in order for the City government to maximize its effort to collect revenues, it is imperative that a Branch Office of the City Treasurer's Office be established at Area VII in District II to serve the Barangay Holy Spirit, Batasan Hills, Commonwealth, Payatas, Bagong Silangan and adjoining areas thus the necessity of this Ordinance.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

Section 1. There shall be established in Area VII, District II a Branch Office of the City Treasurer's Office.

Section 2. The Branch Office shall consist of the following personnel:

One (1) CHIEF OF OFFICE who should be a Deputy Treasurer with an item equivalent to Local Revenue Collection Officer III.

One (1) ASSISTANT CHIEF OF OFFICE whose item is equivalent to Local Revenue Collection Officer II

Three (3) COLLECTORS whose item should be equivalent to Collection Officer I.

Three (3) CASUAL EMPLOYEES to perform clerical functions.


Appointments should be in accordance with the Civil Service Laws, Rules and Regulations.

SECTION 3. The City Treasurer's Branch Office shall be responsible in the collection of taxes imposed by the City government such as Business Taxes, Real Estate Taxes, Community Tax Certificate, CC1-Corporation Professional Tax Receipt, Health Certificates, Occupational Permit and Transfer Tax.

SECTION 4. The Office of the City Mayor through the City Treasurer's Office shall adopt guidelines for the implementation of this ordinance.

SECTION 5. This Ordinance shall take effect upon its approval.
