ORDINANCE NO. SP-1218S:2002

**AN ORDINANCE CREATING PLANTILLA POSITIONS AS SUPPORT STAFF IN THE OFFICE OF THE PEOPLE'S LAW ENFORCEMENT BOARD AND PROVIDING THE NECESSARY FUNDS THEREFOR.**

WHEREAS, Section 43 of Republic Act 6975 also known as the "Department of Interior and Local Government Act of 1990" mandated the creation of the People's Law Enforcement Board by the Sangguniang Panlungsod;

WHEREAS, pursuant to said law, the Quezon City Government has organized the People's Law Enforcement Board into four (4) districts;

WHEREAS, considering the permanent existence of the Board unless the law is repealed plus the mounting dockets of cases against erring policemen it is imperative that a regular staff to assist the BOARD in the discharge of its function, be designated.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

Section 1. To assist the BOARD of its function, the following plantilla positions are hereby created:


B. Four (4) Stenographic Recorder Officer IV	13	P 135,276.00

Section 2. The amount necessary for the positions created in Sec. I hereof shall be chargeable against the special project fund of the City Mayor.


Section 3. The Office of the Mayor thru the Personnel Office shall take charge in the implementation of this ordinance.
