ORDINANCE NO. SP-**1376**, S-2004

AN ORDINANCE NAMING THE CREEK PASSING THROUGH THE AREA OF AND WITHIN THE TERRITORIAL JURISDICTION OF BARANGAY BAGBAG, QUEZON CITY AS "OLD PALIGUAN CREEK".

WHEREAS, Barangay Resolution No. 133 Series of 2003 of Barangay Bagbag, states:

"Now therefore be it resolved, as it is hereby resolved by the Barangay Council of Barangay Bagbag in the session duly assembled a Resolution for the naming of the creek with a width of approximately two and a half (2 ½) meters and with a length passing through this area of Barangay to Old Paliguan Creek".

WHEREAS, the Sangguniang Panlungsod is empowered to protect its environment within the said creek being a part of public domain must be named its proper identification for protection.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:


SECTION 1. There shall be named that portion of the creek with an area of approximately two and a half (2 ½) meters passing through Barangay Bagbag as "OLD PALIGUAN CREEK".

SECTION 2. The Office of the City Mayor through the Office of the City Librarian shall take charge in the implementation of this Ordinance.


SECTION 3. This Ordinance shall take effect upon compliance with the pertinent provisions of the Local Government Code.


