ORDINANCE NO. SP- 1390, S-2004

AN ORDINANCE REQUIRING ALL CINEMA OWNERS AND OPERATORS IN QUEZON CITY TO INCREASE THE PRICES OF THEIR ADMISSION TICKETS BY ONE PESO (P1.00) COVERING THE PERIOD FROM APRIL 1 TO 30, 2004 TO SUPPORT THE PROGRAMS AND ACTIVITIES OF THE BOY SCOUTS OF THE PHILIPPINES, QUEZON CITY CHAPTER.

WHEREAS, to ensure the realization of their projects and programs, the City government should help the Boy Scouts of the Philippines in sourcing funds.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. All cinema owners and operators in Quezon City are hereby required to increase their admission fee by One Peso (P1.00) covering the period from April 1 to 30, 2004.



SECTION 3. This Ordinance shall take effect upon its approval.




