ORDINANCE NO SP- **1405**, S-2004

AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00) OR SO MUCH THEREOF, FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY, FOR THE CONSTRUCTION/ERECTION OF ANDRES BONIFACIO MONUMENT/STATUE IN NOVALICHES PUBLIC PLAZA, QUEZON CITY.

WHEREAS, in the struggle for freedom, Andres Bonifacio recruited some Novaleños including Colonels Geronimo, Luis Malinis and Canuto Dumalay that eventually led to the restoration of Philippine democracy,

WHEREAS, in honor and in recognition of his heroic acts especially to the people of Novaliches, Andres Bonifacio deserved to have a statue in Novaliches Plaza along with the monument of Dr. Jose P. Rizal;

WHEREAS, the erection of Andres Bonifacio Monument in Novaliches Public Plaza will not only perpetuate the memory of a great man, but also serve as a remembrance for the idealist young generation.


NOW, THEREFORE,

SECTION 2. This Ordinance shall take effect upon its approval.


