ORDINANCE NO. SP- 1461, S-2004

AN ORDINANCE IMPOSING AN ADDITIONAL ONE PESO (P1.00) TO ADMISSION FEES IN ALL CINEMAS IN QUEZON CITY FROM MARCH 1 TO 31, 2005, THE PROCEEDS THEREOF TO BE DONATED TO THE SENTRO NG MANGGAGAWANG FILIPINA, QUEZON CITY FOR THE PURPOSE OF SUPPORTING ITS PROGRAMS FOR QUEZON CITY.

WHEREAS, Sentro ng Manggagawang Filipina, Quezon City is a policy resource and research non-government, non-profit organization committed to advocacy work and services for the protection, rights and development of Filipino women and young workers, primarily migrant workers and also involved in integrating gender and development framework, issues and processes in migration, labor and local governance;

WHEREAS, in line with the creation of the Sentro ng Manggagawang Filipina, Quezon City committed to advance gender responsive governance, the Quezon City government would like to share its vision for a gender-responsive, quality city and promote gender advocacy values within and outside the city, through a gender mainstreaming program in various field such as in media;

WHEREAS, to show the support of the Quezon City government, it intends to increase by One Peso (P1.00) the admission fees in cinemas in the city, the proceeds thereof to be donated to the Sentro ng Manggagawang Filipina, Quezon City.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED.


SECTION 1. All cinema owners and operators in Quezon City are hereby required to increase theater admission fee by One Peso (P1.00) for the entire month of March 2005.
