ORDINANCE NO. SP- 1518, S-2005

AN ORDINANCE REQUIRING ALL CINEMA OWNERS AND OPERATORS IN QUEZON CITY TO INCREASE THE PRICES OF THEIR ADMISSION TICKETS BY ONE PESO (P1.00) COVERING THE PERIOD FROM JUNE 1 TO 30, 2005 TO SUPPORT THE PROGRAMS AND ACTIVITIES OF THE METRO MANILA PHILIPPINE COUNCILORS LEAGUE (MMPCL).

SECTION 1. All cinema owners and operators in Quezon City are hereby required to increase their theater admission fees by One Peso (P1.00) covering the period from June 1 to 30, 2005.

SECTION 3. This Ordinance shall take effect immediately upon its approval.


