ORDINANCE NO. SP- 1519, S-2005

AN ORDINANCE REQUIRING ALL CINEMA OWNERS AND OPERATORS IN QUEZON CITY TO INCREASE THE PRICES OF THEIR ADMISSION TICKETS BY ONE PESO (P1.00) COVERING THE PERIOD FROM JULY 1 TO 31, 2005 TO SUPPORT THE PROGRAMS AND ACTIVITIES OF THE BOY SCOUTS OF THE PHILIPPINES (BSP) QUEZON CITY CHAPTER.





SECTION 3. This Ordinance shall take effect immediately upon its approval.


