AN ORDINANCE AUTHORIZING THE MERGING OF THE INSPECTION AND EXAMINATION DIVISION UNDER THE OFFICE OF THE CITY TREASURER AND DESIGNATION OF ALL PLANTILLA TREASURY INSPECTORS THEREIN AS REGULAR REVENUE EXAMINERS.

WHEREAS, the City Council is empowered to pass upon measures to maximize the use of its resources to raise revenues for the programs, objectives and priorities of the city;

WHEREAS, the City Treasurer pursuant to its mandate under Section 470 (d) (1) has advised the City Council of the ~~xxx~~ proposed DESIGNATION OF ALL TREASURY INSPECTORS AS REGULAR REVENUE EXAMINERS AND RECONSTITUTION OF THE INSPECTION AND EXAMINATION DIVISION INTO AN INTEGRATED EXAMINATION DIVISION OF THE CITY TREASURER'S OFFICE ~~xxx~~ a copy is attached as annex "A".

WHEREAS, in order to attain optimum capability of the Office of the City Treasurer to maximize tax revenue collection, this Ordinance is imperative.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. There shall be merged and consolidated the Inspection and Examination Sections into an integrated Examination Division under the Office of the City Treasurer;


SECTION 2. The duties and functions as defined in the Plantilla for Treasury Inspectors shall be modified from field inspection to the examination of the books-of-accounts of businesses in the city.

SECTION 3. The Treasury Inspectors shall be designated as Regular Revenue Examiners but shall continue without diminution or increase in salary.


SECTION 4. The Office of the City Treasurer shall formulate a guideline in the implementation of this Ordinance.

SECTION 5. This ordinance shall take effect upon its approval.
