ORDINANCE NO. SP- **1597** , S-2005
(PO2005-190)

AN ORDINANCE AMENDING SP-1085, S-2001, OTHERWISE KNOWN AS "AN ORDINANCE AUTHORIZING THE HONORABLE CITY MAYOR ISMAEL A. MATHAY, JR. TO EXPROPRIATE THE PARCELS OF LAND SITUATED IN BANLAT, QUEZON CITY, IDENTIFIED AS LOT 1046-B-1 WITH AN AREA OF FIVE HUNDRED FIFTY (550) SQUARE METERS, TO BE AMENDED AS LOT 1045-II, LOT 1045-G, LOT 1045-F, LOT 1045 F-4, LOT 1045-F-5, LOT 1045-F-6 AND LOT 1045-F-7 WITH A TOTAL AREA OF THREE THOUSAND EIGHT HUNDRED (3,800) SQUARE METERS, FOR THE PURPOSE OR ERECTING THE TANDANG SORA SHRINE AND THE RELEASE OF FUNDS NEEDED THEREFORE TO BE TAKEN FROM THE OFFICE OF THE CITY MAYOR.

WHEREAS, Ordinance No. SP-1085, S-2001 was enacted for the purpose of expropriating a parcel of lot intended for erecting Tandang Sora Shrine at Barangay Tandang Sora, with an area of 1,906 square meters;

WHEREAS, the location of the proposed lot to be expropriated is not conducive as the shrine of the national heroine or the same is surrounded by informal settlers or squatters and the lot area is insufficient to be developed into promenade, hence, there is a necessity to amend the ordinance.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Section 1 of SP-1085 is hereby amended to read as follows:


"Section 1. The City Mayor is hereby authorized to expropriate the parcel of land otherwise known and identified as Lot 1045-H (TCT No. 77173 (252184)); Lot 1045-G (TCT No. 253594); Lot 1045-F-3 (TCT No. 265795); Lot 1045-F-4 (TCT No. 265796); Lot 1045-F-5 (TCT No. 265797); Lot 1045-F-6 (TCT No. 265798 and Lot 1045-F-7 (TCT No. 265799) owned and registered in the name of Metro Hauling Contractor, Inc., except for Lot 1045-H (TCT No. 77173) owned by Spouses Godofredo D. Limcangco and Catherine Aquino Limcangco containing a total land area of 3,800 square meters."

SECTION 2. The funds necessary in the expropriation proceedings will be taken from the available funds of the City Mayor.

SECTION 3. The Office of the City Mayor, through the City Legal Officer and the City Assessors Office, shall take charge in the implementation of this ordinance.

SECTION 4. This Ordinance shall take effect upon approval.
