AN ORDINANCE NAMING THE FOOTBRIDGE AT THE CORNER OF A. BONIFACIO AND 11TH AVENUES, BARANGAY BALINGASA, BALINTAWAK, QUEZON CITY, AS THE "AGATHA EUNICE M. MADRILEJO FOOTBRIDGE".

WHEREAS, over the years, many pedestrians have lost their lives or sustained injuries while crossing the vicinity of A. Bonifacio corner 11th Avenue, Barangay Balingasa, Balintawak, Quezon City and one of them was four year old Agatha Eunice M. Madrilejo who died on September 23, 1985;

WHEREAS, to avoid the occurrence of similar tragic accidents, the local government of Quezon City, pursuant to its mandate of keeping the city streets and thoroughfares safe for all commuters and road users, has caused to built a pedestrian footbridge at the corner of A. Bonifacio and 11th Avenues, Barangay Balingasa, Balintawak, Quezon City;

WHEREAS, in recognition of Barangay Captain Erlinda M. Madrilejo's efforts to make the construction of the footbridge possible, it is only fitting to dedicate the said pedestrian footbridge in remembrance of her late daughter, Agatha Eunice M. Madrilejo.


NOW, THEREFORE,
