ORDINANCE NO. SP-**1725** S-2006
(PO2005-142)

AN ORDINANCE NAMING THE FIRST AND SECOND STREETS ALONG PHILAND DRIVE FROM THE CORNER OF TANDANG SORA AVENUE IN BARANGAY PASONG TAMO, QUEZON CITY, AS FERNANDO P. EUGENIO STREET AND JUANARIA P. EUGENIO STREET, RESPECTIVELY.

WHEREAS, the first and second streets along Philand Drive from the corner of Tandang Sora, Quezon City, are still unnamed;

WHEREAS, the unnamed streets are city-owned property, the same being constructed, operated and maintained by the City government;

WHEREAS, the proposed names of the said unnamed streets are derived from the names of the late Spouses Fernando P. Eugenio and Juanaria P. Eugenio, who generously donated the parcel of land where the present Barangay Hall of Barangay Pasong Tamo is located;

WHEREAS, the naming of first and second streets has been unanimously and favorably recommended by the Sangguniang Barangay of Pasong Tamo through its Resolution No. 05-097, S-2005, copy thereof is attached.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:


SECTION 1. The unnamed first and second streets along Philand Drive from the corner of Tandang Sora Avenue in Barangay Pasong Tamo, Quezon City, is hereby named to Fernando P. Eugenio Street and Juanaria P. Eugenio Street, respectively.

SECTION 2. The Office of the City Engineer shall take charge in the installation of the necessary street sign pursuant to the provisions of Section 1 hereof.


SECTION 3. The Office of the Secretary to the Sanggunian shall furnish copy of this ordinance to the Office of the President of the Philippines, the Representative of the Legislative District concerned, and the Bureau of Post, for their information.

SECTION 4. This Ordinance shall take effect upon its approval.
