AN ORDINANCE IMPOSING AN ADDITIONAL ONE PESO (P 1.00) TO ADMISSION FEES IN ALL CINEMAS IN QUEZON CITY, FROM FEBRUARY 1 TO 29, 2008, THE PROCEEDS THEREOF TO BE DONATED TO THE QUEZON CITY RED CROSS IN CONNECTION WITH ITS COMMUNITY-BASED DEVELOPMENT PROJECTS.

WHEREAS, they also wanted to improve their facilities in blood transfusion and conducting a citywide campaign on voluntary blood donation in order to meet the spiraling needs of blood of our countless indigent patients whose recovery is retardate due to unavailability of blood;

WHEREAS, this program will only materialize if they have a sufficient resources to support the project;

WHEREAS, to show the support of the Quezon City government, it intends to increase by One Peso (P1 00) the admission fees in cinemas in the City, the proceeds thereof to be donated to Quezon City Red Cross.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

Section 1. Admission Fees in all cinemas or movie houses in Quezon City are hereby increased by One Peso (P1.00) from February 1 to 29, 2008.

Section 2. The proceeds of the One Peso (P1.00) prescribed in Section 1 hereof shall be donated in connection with Quezon City Red Cross Community Based Development Project.
