AN ORDINANCE APPROVING THE ANNUAL BUDGET OF THE QUEZON CITY GOVERNMENT FOR CALENDAR YEAR 2008 IN THE TOTAL AMOUNT OF EIGHT BILLION SIX HUNDRED MILLION PESOS (P8,600,000,000.00) COVERING THE VARIOUS EXPENDITURES FOR THE OPERATION OF THE CITY GOVERNMENT FOR YEAR 2008, AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE.



**BE IT ORDAINED BY THE CITY COUNCIL OF
QUEZON CITY IN REGULAR SESSION ASSEMBLED:**

SECTION 1. *The Annual Budget of the Quezon City government for Calendar Year 2008 in the total amount of Eight Billion Six Hundred Million Pesos (P8,600,000,000.00) covering the various expenditures for the operation of the City government of the year 2008 is hereby approved.*

7. *Personnel Schedule*



SECTION 2. There is hereby appropriated from the General Fund the sum of Eight Billion Six Hundred Million Pesos (P8,600,000,000.00) or so much thereof as maybe necessary, to be taken from the estimate of revenues certified as available for appropriation by the City Treasurer as contained in the budget documents.


SECTION 3. If, for any reason, any section or provision of this Ordinance is declared invalid or unconstitutional, other sections or provisions thereof which are not affected thereby shall continue to be in full force and effect.

SECTION 4. This Ordinance shall take effect immediately upon its approval.


