(PO2008-43)

AN ORDINANCE IMPOSING A FARE INCREASE FOR ALL TRICYCLE FOR HIRE IN QUEZON CITY FROM SIX PESOS (P6.00) TO SEVEN PESOS AND FIFTY CENTAVOS (P7.50) PER PERSON IN REGULAR TRIPS AND FOR SPECIAL TRIPS FROM TWELVE PESOS (P12.00) TO SIXTEEN PESOS (P16.00) AND FOR THE FIRST KILOMETER AN ADDITIONAL OF ONE PESO (P1.00) PER KILOMETER.

WHEREAS, the continuous increase in the price of gasoline and which is almost weekly has reached a record high of Ninety Eight Dollar (\$98) per barrel as of November 4, 2007;

WHEREAS, the previous Sixty Seven Dollar (\$67) per barrel when it was last petitioned for fare increase on August 16, 2005 and the price of unleaded gasoline as of November 11, 2007 is the 15th times increase per liter from P41.73 to P44.76 per liter;

WHEREAS, a reasonable tricycle fare increase is indeed necessary to maintain the viability of tricycle operation not only as a source of livelihood among almost Twenty Four Thousand (24,000) tricycle operators and drivers but also as an indispensable mode of transport system for a considerable portion of the residents of Quezon City.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:


SECTION 1. *All tricycle for hire in Quezon City are hereby required to have a fare increase from Six Pesos (P6.00) to Seven Pesos and Fifty Centavos (P7.50) per person in Regular Trip and for Special Trips from Twelve Pesos (P12.00) to Sixteen Pesos (P16.00) and for First Kilometer an additional One Peso (1.00) per kilometer.*

SECTION 2. This Ordinance shall take effect immediately upon its approval.
