ORDINANCENO. SP. 1847 (PO2008-19)

AN ORDINANCE AUTHORIZING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO ACQUIRE BY PURCHASE OR BY EXPROPRIATION PROCEEDINGS THAT PORTION OF A PARCEL OF LAND WITH AN AREA OF FIFTEEN (15) SQUARE METERS, SITUATED IN BARANGAY ISIDRO GALAS, QUEZON CITY, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED N-225762 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF ALEGAR CORPORATION, TO BE USED AS A ROAD RIGHT-OF-WAY (ALLEY) FOR THE RESIDENTS OFDQVBENITO STREET. ANDAPPROPRIATING THE NECESSARY FUNDS FOR THEPURPOSE.

WHEREAS, a portion of a parcel of land with an area of fifteen (15) square meters, situated in Barangay San Isidro Galas, Quezon City, covered by Transfer Certificate of Title Numbered N-225762 of the Registry, of Deeds of Quezon City, registered in the name of Alegar Corporation, has been used by residents of Don Benito Street in Block 4 as their entrance and exit to Manila and Quezon City;

WHEREAS, it is now necessary for the Quezon City government to exercise its power of eminent domain to finally address the right-of-way problem pursuant to the provisions of the Local Government Code;

WHEREAS, the owner of the property is willing to sell the subject property for the price of P20,000.00 per square meters to be used exclusively as an alley;

WHEREAS, the acquisition of the subject portion will mean an opportunity to improve the existing Barangay road which will contribute in providing better access to the residents thereat.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. The City Mayor, Honorable Feliciano R. Belmonte, Jr., is hereby authorized to acquire by purchase or by expropriation proceedings, that portion of a parcel of land with an area of fifteen (15) square meters, situated in Barangay San Isidro Galas, Quezon City, covered by Transfer Certificate of Title Numbered N-225762 of the Registry of Deeds of Quezon City, registered in the name of Alegar Corporation, to be used as a road right-of-way for the residents of Don Benito Street, and appropriating the necessary funds for the purpose.

SECTION 2. The necessary amount is hereby appropriated from any available funds in the City Treasury for the cost of the subject property, which is being proposed to be acquired by the City government.

SECTION 3. This Ordinance shall take effect upon its approval.
