(PO2008-97)

AN ORDINANCE AMENDING ORDINANCE NO. SP-1842, S-2008, ENTITLED "AN ORDINANCE IMPOSING A FARE INCREASE FOR ALL TRICYCLE FOR HIRE IN QUEZON CITY FROM SIX PESOS (P6.00) TO SEVEN PESOS AND FIFTY CENTAVOS (P7.50) PER PERSON IN REGULAR TRIPS AND FOR SPECIAL TRIPS FROM TWELVE PESOS (P12.00) TO SIXTEEN PESOS (P16.00) AND FOR THE FIRST KILOMETER AN ADDITIONAL OF ONE PESO (P1.00) PER KILOMETER."

WHEREAS, there is an ambiguity of interpretation with regard to the content of the said title;

WHEREAS, the said title of the ordinance will result confusion not only for the tricycle operators and drivers concerned but to the riding public as well on how to impose additional one peso (P1.00) with their tricycle fare;

WHEREAS, to be able to clear the ambiguous content and interpretation through this ordinance will give clarification as to precise and true intention of the ordinance;

WHEREAS, cognizant of the need to obtain a multi-sectoral opinion on the issue, the Quezon City Tricycle Franchising Board conducted a Public Hearing on June 5, 2008 at 2:00 P.M. at Carlos Albert Hall, Quezon City Hall, Quezon City and came out with the consensus that tricycle fare increase is indeed tolerable.

NOW, THEREFORE,



BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Ordinance No. SP-1842, Series of 2008, is hereby amended as previously read as follows:

"AN ORDINANCE IMPOSING A FARE INCREASE FOR TRICYCLE FOR HIRE IN QUEZON CITY FROM SIX PESOS (P6.00) TO SEVEN PESOS AND FIFTY CENTAVOS (P7.50) PER PERSON IN REGULAR TRIPS AND FOR SPECIAL TRIPS FROM TWELVE PESOS (P12.00) TO SIXTEEN PESOS (P16.00) FOR THE FIRST KILOMETER AN ADDITIONAL OF ONE PESO (P1.00) PER KILOMETER."

and must be read:

"AN ORDINANCE IMPOSING A FARE INCREASE FOR ALL TRICYCLE FOR HIRE IN QUEZON CITY FROM SIX PESOS (P6.00) TO SEVEN PESOS AND FIFTY CENTAVOS (P7.50) PER PERSON IN REGULAR TRIPS AND FOR SPECIAL TRIPS FROM TWELVE PESOS (P12.00) TO FIFTEEN PESOS (P15.00) AND AN ADDITIONAL OF ONE PESO (P1.00) FOR EVERY KILOMETER IN EXCESS THEREOF FOR BOTH REGULAR AND SPECIAL TRIPS."

SECTION 2. Section 1 of Ordinance No. SP-1842, Series of 2008 is hereby amended, so as to include the 20% discount to Senior Citizens, Disabled Persons and Student Fares and shall be read as follows:

Section 1. "Tricycle fare in Quezon City is hereby increase in accordance with the following schedule:

- A. REGULAR TRIPS=Seven Pesos and Fifty Centavos (P7.50) for the first kilometer plus One Peso (P1.00) for every kilometer in excess thereof.
- B. SPECIAL TRIPS =Fifteen Pesos (P15.00) for the first kilometer plus One Peso (P1.00) for every kilometer in excess thereof.
- C. SENIOR CITIZENS, DISABLED PERSONS AND STUDENT FARES- 20% DISCOUNT, to wit:

REGULAR TRIPS = Six Pesos (P6.00) for the first kilometer and Eighty Centavos (P0.80) for every kilometer in excess thereof.

SPECIAL TRIPS = Twelve Pesos (P12.00) for the first kilometer and Eighty Centavos (P0.80) for every kilometer in excess thereof.


SECTION 3. Any person found violating the provisions of this ordinance shall be penalized by a fine of Five Thousand Pesos (P5,000.00) or imprisonment of six (6) months of both such fine and imprisonment at the discretion of the Court.




