AN ORDINANCE REQUIRING ALL CINEMA OWNERS AND OPERATORS TO INCREASE TICKET PRICES BY ONE PESO (P1.00) FOR THE ENTIRE MONTH OF OCTOBER 2008 FOR THE PURPOSE OF SUPPORTING THE SCOUTING PROGRAM OF THE QUEZON CITY GIRL SCOUT.

WHEREAS, the said council has been involved not only in the enhancement of the physical and moral aspects of our female youths but also assists other organizations such as Alay Lakad Foundation, Department of Social Welfare and Development (DSWD), Tulong Bata Project Foundation, among others;

WHEREAS, Girl Scout of the Philippines has been known locally and internationally of its bold involvement in drug prevention, social and civic works, tree planting, clean and green, Adopt-A-Purok Program and other Religious activities;

WHEREAS, the Girl Scout Movement, which serves as a training ground for young women, needs our support for its projects/programs and activities through minimal contributions of the general public.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. All cinema owners and operators in Quezon City are hereby required to increase theater tickets price by One Peso (P1.00) for the entire month of October 2008.

SECTION 2. All proceeds from this fund raising shall be used exclusively to finance all programs and activities of the Quezon City Girl Scouts.
