ORDINANCENO. SP. 1866, S-2008 (PO2008-89)

AN ORDINANCE IMPOSING A ONE PESO (P1.00) INCREASE IN ADMISSION TICKETS IN ALL CINEMAS IN QUEZON CITY, COVERING THE PERIOD FROM 01 TO 30 NOVEMBER 2008, THE PROCEEDS THEREOF TO BE DONATED TO INTERNATIONAL SOCIAL SERVICE PHILIPPINES (ISS PHILS) INCORPORATED FOR THE LAUNCH OF THEIR SPECIFIC PROGRAMS AND PROJECTS AND THEIR THRUSTS OF ALLEVIATING THE PLIGHT OF THE VICTIMS OF HUMAN TRAFFICKING AND CONCERNS OF THE OVERSEAS FILIPINO WORKERS.

WHEREAS, the current ISSP Board of Trustees and staff are focused on alleviating the plight of victims of human trafficking and labor migrants who have been traumatized while working abroad as well as families of Overseas Filipino Workers who are dependent on the remittances that these OFWs can afford and which frequently are meager indeed;

WHEREAS, ISSP Chairman of the Board of Trustees, Justice Leonor Ines Luciano, is requesting the Sangguniang Panlungsod for the grant of additional One Peso (P1.00) on the admission ticket in all cinemas in Quezon City for a period of one month in support to the programs and projects of the ISSP to improve the appalling conditions of their target clienteles;


WHEREAS, the Quezon City government's support is hereby solicited by way of increasing the admission fees by One Peso (P1.00) in support for our fellow countrymen and women who are victims of human trafficking and the Overseas Filipino Workers known as our modern day heroes.

NOW, THEREFORE,

BE I'T ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. ADMISSION FEES - Admission Fees in all cinema/movie houses in Quezon City are hereby increased by One Peso (P1.00) from 01 to 30 November 2008.

SECTION 2 PROCEEDS — The proceeds of admission fee increase as prescribed in Section 1 of this Ordinance shall be donated to the International Social Service Philippines (ISS Phils) Incorporated to support its specific programs and projects.
