ORDINANCE NO. SP-1876, S-2008

AN ORDINANCE APPROPRIATING THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (P500,000.00) TO SERVE AS INCENTIVE FOR THE MOST ECO-FRIENDLY SCHOOLS AND CREATING A COMMITTEE TO IMPLEMENT THE SAME.

WHEREAS, it is imperative to allocate funds necessary therefore in order to serve as incentive to Eco-Friendly Schools to strengthen and continuously build-up the capability of the City to protect its environment from the problem of indiscriminate throwing of garbage;

WHEREAS, it is also imperative to educate our students to learn the 3R's of waste disposal - reuse, reduce and recycle;

WHEREAS, the City Council is mandated to formulate legislative measures to promote the welfare of its constituency.


NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY
IN REGULAR SESSION ASSEMBLED:




