ORDINANCE NO. SP.1920 S-2009

AN ORDINANCE RENAMING PELAEZ EXTENSION STREET, BARANGAY BAYANIHAN, DISTRICT III, QUEZON CITY TO "PEDRO CRUZ MARTINEZ STREET".

WHEREAS, streets, avenues, boulevards, parks, playgrounds, historical spots and other places are so named as to signify and perpetuate the greatness and nobility of certain personage of note, or the significance of certain events;

WHEREAS, Section 13, paragraph b (2) of the Local Government Code of 1991 provides that:

"The Sangguniang of highly urbanized cities and component cities whose charters prohibited their voters from voting for provincial elective officials, hereinafter referred to in this Code as independent component cities, may, in consultation with the Philippine Historical Commission, change the name of the following within its territorial jurisdiction";

WHEREAS, in 1972, Barangay Bayanihan was not its name during that time, it was only the club formed by Mr. Pedro Martinez, and Mr. Constantino Arcilla, Jr., as officers of the club, who were appointed by Assemblymen that time and gave the name Barangay Bayanihan;

WHEREAS, Barangay Bayanihan was created on August 19, 1972 and has a total land area of 6,456.66 by virtue of Executive Order No. 029 and PD-86-2010;

WHEREAS, Mr. Pedro Martinez was the first elected Barangay Captain or Tenyente Del Barrio of Barangay Bayanihan in 1975 but he died not completing his term;

WHEREAS, in order to extol the name of a person, it is most befitting to use his name on a street where motorists and visitors may passed therein will easily remember him.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. PELAEZ EXTENSION STREET in Barangay Bayanihan, District III, is hereby renamed as "PEDRO CRUZ MARTINEZ STREET."

SECTION 2. To avoid the inconvenience that may arise in the delivery of postal matters and in guiding people accustomed to the old name, "Pelaez Extension Street" shall be printed at the bottom of the signage "PEDRO CRUZ MARTINEZ STREET" for at lease two (2) years.

SECTION 3. The Office of the President, the Congressman of the 3rd District of Quezon City and the Director of the Postal Services Office, as well as all agencies concerned, shall be notified of this ordinance pursuant to Section 13, paragraph (h) of the Local Government Code of 1991.
