AN ORDINANCE MAKING ROAD 10 CORNER ROAD 8 TO MINDANAO AVENUE BARANGAY PROJECT 6, QUEZON CITY, A ONE-WAY TRAFFIC FROM 11:00 AM TO 2:00 PM.

WHEREAS, traffic congestion occurs everyday during lunch time because of some restaurants and eateries located at Road 10;

WHEREAS, the Barangay Council of Barangay Project 6 passed a Resolution to make Road 10 corner Road 8 to Mindanao Avenue a one-way traffic from 11:00 am to 2:00 pm to ease the traffic congestion for the benefit of the residents and motorists;

WHEREAS, vehicles shall park at one side of Road 10 within the yellow lane from Mindanao Avenue corner of Alley 27;

WHEREAS, no vehicles can park or exit along the side streets of Road 10 corner Road 8;

WHEREAS, traffic will be manned by volunteer traffic aides duly authorized by the Barangay.
