ORDINANCE NO. SP-**1955**, S. 2009

**AN ORDINANCE REQUIRING ALL CINEMA OWNERS AND OPERATORS TO INCREASE TICKET PRICES BY ONE PESO (P1.00) FOR THE ENTIRE MONTH OF OCTOBER 2009, THE PROCEEDS THEREOF TO BE DONATED TO THE MOWELFUND IN CONNECTION WITH DEVELOPMENT PROJECT.**

*WHEREAS, MOWELFUND is a non-stock, non-profit social welfare, educational and industrial development foundation, which aim to develop and uplift the state of Philippine film culture through educational and development initiatives, responsive welfare programs, local and international linkage and partnership and resources generation;*

*WHEREAS, the MOWELFUND has a social welfare programs aimed the poor and underpaid movie workers, who work on a per-picture basis such as stuntmen, bit player, technician, make-up artist, cameraman, checkers, props men and other film crew who do not have private insurance coverage and SSS benefits;*

*WHEREAS, the program includes medical, surgical, death aid, containing medical benefits, free clinic day, livelihood and housing program;*

*WHEREAS, to show the support of the Quezon City Government, it intends to increase by One Peso (P1.00) the admission fees in cinemas in the city, the proceeds thereof to be donated to MOWELFUND.*

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. All cinema and movie house owners and operators in Quezon City are hereby required to increase theater admission prices by One Peso (P1.00) for the entire month of October 2009.

SECTION 2. The proceeds of the One Peso (P1.00) prescribed in Section 1 hereof shall be donated in connection with MOWELFUND Development Project.

SECTION 3. The City Treasurer is directed to submit a report of the sum collected for the purposed to the City Council prior to the release thereof to its lawful beneficiary the MOWELFUND.


