ORDINANCE NO. SP-**1988**S-2009

**AN ORDINANCE DECLARING EUGENIO LOPEZ STREET, SGT. ESGUERRA STREET AND MOTHER IGNACIA AVENUE, BARANGAY SOUTH TRIANGLE, QUEZON CITY AS ONE-WAY STREET.**

*WHEREAS, R.A. No. 7160 provides that local government unit, through an ordinance, may temporary close and regulate local street, road, thoroughfares, or any public place where shopping malls, Sunday, flea or night market, or shopping areas may be established and where goods, merchandise, foodstuffs, commodities, or articles of commerce may be sold and dispensed to the general public;*

*WHEREAS, Chapter III, Article III, Section 458, paragraph 5 (v) of the Local Government Code of 1991 provides that the Sangguniang Panlungsod may regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and paragraph 5 (vi) which states that the city through the Sangguniang Panlungsod may regulate traffic on all streets and bridges;*

*WHEREAS, R.A. No. 7160, also known as the Local Government Code of 1991, provides that the function of the Barangay is to submit to the Sangguniang Panlungsod or Sangguniang Bayan such suggestions or recommendations as it may see fit for the improvement of the Barangay or for the welfare of the inhabitants thereof;*

*WHEREAS, the Barangay Council of Barangay South Triangle passed Resolution No. 505, S-2009 entitled "A Resolution urging the Quezon City Council to enact an ordinance making the streets facing the ABS/CBN Channel 2 Compound as one way street.*

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN  
REGULAR SESSION ASSEMBLED:


SECTION 1. The following streets in Barangay South Triangle are hereby declared as one-way.

- a. Mother Ignacia Avenue (from Sgt. Albano to Sgt. Esguerra Street)
- b. Sgt. Esguerra Street (from Mother Ignacia Avenue to Eugenio Lopez Street)
- c. Eugenio Lopez Street (from Sgt. Esguerra Street to Mother Ignacia Avenue)


SECTION 2. The Barangay South Triangle is hereby authorized to install signage indicating that the abovementioned streets are one-way flow traffic only.

SECTION 3. The Department of Public Order and Safety (DPOS), Traffic Enforcer of Barangay South Triangle shall ensure the strict implementation of this Ordinance and hereby given plenary powers and authority to carry out the provision of this ordinance.
