BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:


SECTION 1. All cinema and movie house owners and operators in Quezon City are hereby mandated to increase theater admission tickets by One Peso (P1.00) for the entire month of May 2010.

SECTION 2. The proceeds of the One Peso (P1.00) increase prescribed in Section 1 hereof shall be donated to the Movie Writers Welfare Foundation, in connection with its development projects.

SECTION 3. The City Treasurer is directed to submit a report of the sum collected for the purpose to the City Council prior to the release thereof to its lawful beneficiary, the Movie Writers Welfare Foundation.

SECTION 4. This Ordinance shall take effect upon its approval.


