ORDINANCE NO. SP-**1996**, S-2010

AN ORDINANCE IMPOSING A ONE (P1.00) INCREASE IN ADMISSION TICKETS IN ALL CINEMAS IN QUEZON CITY COVERING THE PERIOD OF JULY 1 TO 31, 2010, THE PROCEED THEREOF TO BE DONATED TO INTERNATIONAL SOCIAL SERVICE PHILIPPINES (ISS PHILS) INCORPORATED FOR THEIR TRANSIT AND PROCESSING CENTER FOR MIGRANTS, DISADVANTAGED WOMEN AND CHILDREN AND THE VICTIMS OF HUMAN TRAFFICKING.

WHEREAS, the International Social Service Philippines (ISS Phils) Incorporated is a Non-Government Organization accredited by the 17th Sangguniang Panlungsod through City Ordinance No SP-1799, S-2007;

WHEREAS, ISSP Chairman of the Board of Trustees, Justice Leonor Ines Luciano, is requesting the Sangguniang Panlungsod for the grant of additional One Peso (P1.00) on admission tickets in all Cinemas in Quezon City for a period of One Month in support of the ISSP's Transit and Processing Center for migrants, disadvantaged women and children and victims of human trafficking;

WHEREAS, the proceeds thereof will be utilized for the daily operation of the Transit and Processing Center;

WHEREAS, the Quezon City Government's support is hereby solicited by way of increasing the admission fees of all cinemas in Quezon City by One Peso (P1.00) in support for our fellow countrymen and women who are victims of human trafficking and the Overseas Filipino Workers known as our modern day heroes.


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY
IN REGULAR SESSION ASSEMBLED:

SECTION 1. Admission Fees - Admission Fees in all
cinemas/movie houses in Quezon City are hereby increased by
One Peso (P1.00) from 01 to 31 July 2010.

SECTION 2. Proceeds - The Proceeds of Admission Fee
Increase as prescribed in Section 1 of this Ordinance shall be
donated to the International Social Service Philippines (ISS Phils)
Incorporated and shall be allotted to its Transit and Processing
Center.

SECTION 3. Effectivity - This Ordinance shall take effect
immediately upon its approval.
