ORDINANCE NO. SP-20048-2010

AN ORDINANCE PROHIBITING THE ENTRY OF SIX (6) WHEELERS AND OTHER HEAVY TRUCKS ALONG GREENMEADOWS AVENUE, GIRAFFE STREET AND TEMPLE DRIVE, BARANGAY UGONG NORTE, QUEZON CITY.

WHEREAS, R.A. No. 7160 provides that a local government unit may, pursuant to an ordinance, may regulate traffic on all streets and bridges; prohibit encroachments or obstacles thereon and, when necessary in the interest of public welfare, authorize the removal of encroachments and illegal constructions in public places;

WHEREAS, R.A. No. 7160, also known as the Local Government Code of 1991, provides that the function of the Barangay is to "submit to the Sangguniang Panlungsod or Sangguniang Bayan such suggestions or recommendations as it may see fit for the improvement of Barangay or for the welfare of the inhabitants thereof";

WHEREAS, the Barangay Council of Barangay Ugong Norte seek the assistance of the City government to ban the entry of six wheelers and other heavy trucks within Greenmeadows Avenue, Giraffe Street and Temple Drive, Barangay Ugong Norte, Quezon City through their Barangay Resolution No. 116, S-2009;

WHEREAS, it has been observed that the six (6) wheelers and other heavy trucks have the capacity to cause/contribute to the deterioration as well as the existence of road cracks and potholes within Greenmeadows Avenue, Giraffe Street and Temple Drive in Barangay Ugong Norte;

WHEREAS, there is a need to prohibit entry of six wheelers and other heavy trucks within Greenmeadows Avenue, Giraffe Street and Temple Drive, Barangay Ugong Norte to eradicate/lessen the deterioration of their streets.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. The entry of six (6) wheelers and other heavy trucks along Greenmeadows Avenue, Giraffe Street and Temple Drive, Barangay Ugong Norte, Quezon City is hereby prohibited.

SECTION 2. The Department of Public Order and Safety and the Barangay Council of Barangay Ugong Norte shall ensure the strict implementation of this Ordinance and are hereby given plenary powers and authority to carry out the provision of this ordinance.
