ORDINANCE NO. SP- 2032, S-2010

AN ORDINANCE AMENDING ORDINANCE NO. SP-1924, S-2009, BY CORRECTING THE NAME OF THE ASSOCIATION FROM SAMAHANG MAGKAKAPIT BAHAY NG TATLONG HARI TO SAMAHANG NAGKAKAISA NG TATLONG HARI, INC.

WHEREAS, on February 16, 2009, the City Council of Quezon City approved Ordinance No. SP-1924, S-2009, entitled "An Ordinance authorizing the sale of Four Hundred (400) square meters property acquired by the City Government through an auction sale on June 21, 2007, located at Lot 213, Block Fls-2696-D Tatlong Hari Street, Barangay Gulod, in favor of the bonafide members of the Samahang Magkakapit Bahay ng Tatlong Hari, who are the actual occupants thereat;


WHEREAS, in the said ordinance, the name of the association appears as "Samahang Magkakapit Bahay ng Tatlong Hari";

WHEREAS, the true and correct name of the association is Samahang Nagkakaisa ng Tatlong Hari, Inc., as reflected in its Certificate of Incorporation with the Securities and Exchange Commission (SEC);

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to amend, as it does hereby amend Ordinance No. SP-1924, S-2009, by correcting the name of the association from Samahang Magkakapit Bahay ng Tatlong Hari to Samahang Nagkakaisa ng Tatlong Hari, Inc.


