

ORDINANCE NO. SP-2037, S-2010

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A RESIDENTIAL/COMMERCIAL **TOWNHOUSE** MIXED-USE SUBDIVISION, WITH ONE HUNDRED NINETY (190) RESIDENTIAL TOWNHOUSES AND THIRTY-THREE (33) COMMERCIAL UNITS AN AGGREGATE AREA OF THIRTY THREE THOUSAND FORTY TWO (33,042.00) SQUARE METERS COVERED BY TRANSFER CERTIFICATES OF TITLE NOS. 147391 AND 147392 OF THE REGISTRY OF DEEDS OF QUEZON CITY, AS APPLIED FOR BY THE ETON PROPERTIES PHILIPPINES, INC. WITH OFFICE ADDRESS AT 12/F AYALA BANK CENTER, NO. 6754 AYALA AVENUE, MAKATI CITY, METRO MANILA, IN COMPLIANCE WITH THE MINIMUM REQUIREMENTS OF THE IMPLEMENTING STANDARDS, RULES AND REGULATIONS OF QUEZON CITY ORDINANCE NO. SP-56, S-93 AND PRESIDENTIAL DECREE NO. 957 OR OTHERWISE KNOWN AS THE SUBDIVISION AND CONDOMINIUM BUYER'S PROTECTIVE DECREE.
