**AN ORDINANCE PROMOTING CRIME AWARENESS AND SECURITY IN  
CAMPUSES WITHIN THE TERRITORIAL JURISDICTION OF QUEZON  
CITY.**

*WHEREAS, Section 458 (a) sub-paragraph (1) (ii) of the Local  
Government Code of 1991 empowers the Sangguniang Panlungsod to  
enact measures to prevent and suppress lawlessness, disorder, riot,  
violence, rebellion, or sedition and impose penalties for the violation of  
said ordinances;*

*WHEREAS, it shall be the policy of this City to provide a safe and  
healthy environment for students;*

*WHEREAS, crime occurrence in campuses has steadily risen in  
the past few years, majority of which are fraternity related;*

*WHEREAS, incidents of frat wars, death, physical harm and  
incapacity inflicted to members and non-members continue to hound  
the public, more so, the families victimized by fraternity related  
violence;*

**WHEREAS, there is a need for parents and guardians to be informed of crimes that occurred in a particular institution and of its security policies and procedures.**

**NOW, THEREFORE,**

**BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:**

**SECTION 1. This Ordinance shall be known as the "Campus Security Ordinance of 2010."**

**SECTION 2. The term "Campus" for the purpose of this Ordinance, shall mean any building of property owned or controlled by an institution of higher education with the same reasonably contiguous geographic area and used by the institution in direct support of or related to its education purposes; or any building or property owned or controlled by student organizations recognized by the institution.**

**In cases where branch campuses of an institution of higher education schools within an institution are not reasonably contiguous in geographic area, such entities shall be considered separate campuses for purposes of the reporting requirements of this Ordinance.**

**SECTION 3. Upon the effectivity of this Ordinance, each eligible campus shall begin to collect this year and every year thereafter, prepare, publish, and distribute through appropriate publications, to all current students and employees, and to any applicant for enrollment or employment upon request, an annual security report containing at least the following information with respect to the campus security policies and campus crime statistics of that institution:**

- a. **A statement of current campus policies regarding procedures and facilities for students and a report on criminal actions emergencies occurring on campus, including policies concerning the institution's response to such reports;**
  - b. **A statement of current policies concerning security and access to campus facilities including dormitories inside the campus, and security consideration used in the maintenance of said facilities;**

- c. *A statement of current policies on campus law enforcement including the enforcement authority of security personnel, including their working relationship with national and local police agencies, and policies which encourage accurate and prompt reporting of all crimes to the campus police and the appropriate police agencies;*
- d. *A description of programs designed to inform student and employees about the prevention of crimes;*
- e. *Statistics showing the occurrence on campus, during the most recent school year and two (2) years preceding the school years on which the data are available, including, but not limited to the following criminal offenses reported to campus security authorities or local police agencies, to wit:*
  - (i) *Murder;*
  - (ii) *Rape;*
  - (iii) *Physical Injury;*
  - (iv) *Theft;*
  - (v) *Robbery; and*
  - (vi) *Sexual Harassment;*
- f. *Statistics showing the number of arrests for the following crimes occurring inside the campus.*
  - (i) *Drug abuse violations;*
  - (ii) *Liquor law violations; and*
  - (iii) *Illegal Possession of deadly weapons*
- g. *A statement of policy regarding the possession, use and sale of alcoholic beverages and enforcement of underage drinking laws.*

**SECTION 4.** *Upon the request of the City Mayor or his duly authorized representative, each institution within the territorial jurisdiction of Quezon City shall submit to the Office of the City Mayor a copy of the statistics required under Section 3, paragraphs (e) and (f).*

**SECTION 5.** *The Office of the Mayor shall review such statistics and task the Committee on Education of the City Council in coordination with the representatives of the institutions of higher education, to identify exemplary campus security policies, procedures and practices which have been proven effective in the reduction of campus crime.*

**SECTION 6.** No institution shall deny to an alleged victim of any crime of violence, the result of any disciplinary proceeding conducted by the institution against the alleged perpetrator with respect to such crime.

**SECTION 7.** If any provision or part hereof, is held invalid, the remainder of the Ordinance or the provisions not otherwise affected shall remain valid and subsisting.

**SECTION 8.** Any Ordinance, Executive Order, Rules or Regulations contrary to or inconsistent with the provision of this Ordinance is hereby repealed, modified or amended accordingly.

**SECTION 9.** This Ordinance shall take effect fifteen days after its publication.
