

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF VILLA HERMANO IV SUBDIVISION PHASE 2 (THE PRINCESS HOMES) WITH ONE HUNDRED EIGHTY FIVE (185) LOTS, LOCATED AT LOT 925-NEW-C, (LRC) PSD-61340, PANGANIBAN CORNER DIEGO SILANG STREETS, BARANGAY STA. LUCIA, QUEZON CITY, METRO MANILA, REGISTERED IN THE NAME OF DIANSAPABE & SONS REALTY, INC. COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED 004-2011013193 OF THE REGISTRY OF DEEDS OF QUEZON CITY CONSISTING AN ACGREGATE AREA OF SEVENTEEN THOUSAND EIGHTY ONE (17,081) SQUARE METERS AS REPRESENTED BY ITS PRESIDENT AND GENERAL MANAGER, MARY JANE P. SECTION 1.
