COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED 004-2012005610 OF THE REGISTRY OF DEEDS OF QUEZON CITY, CONSISTING AN AREA OF TEN THOUSAND FIVE HUNDRED SEVENTY THREE SQUARE METERS AND FIFTY SQUARE DECIMETERS (10,573.50) AS REPRESENTED BY ITS VICE PRESIDENT FOR ENGINEERING, ENGR.
