AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF MAGKAKASAMA HOMEOWNERS ASSOCIATION, INC. - WALING-WALING CHAPTER, WITH THIRTY EIGHT (38) LOTS, COMMUNITY MORTGAGE PROGRAM (CMP) OF THE SOCIAL HOUSING FINANCE CORPORATION (SHFC), ORIGINATED BY HERA FOUNDATION, INC., LOCATED AT LOT 44-B, (LRC) PSD-4064, LAURA STREET PUROK 3, AREA 5, BARANGAY MATANDANG BALARA, QUEZON CITY REGISTERED IN THE NAME OF MAGKAKASAMA HOMEOWNERS ASSOCIATION, INC. - WALING-WALING CHAPTER COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED N-264359 OF THE REGISTRY OF DEEDS OF QUEZON CITY, CONTAINING AN AREA OF ONE THOUSAND (1,000) SQUARE METERS, AS APPLIED FOR BY ITS HOA PRESIDENT MR. 
