ORDINANCE NO. SP. 2225 , S-2013

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF CUBAO TOWNHOUSES WITH NINETEEN (19) UNITS/THREE (3)-STOREY TOWNHOUSES LOCATED AT LOTS 1 AND 30 BLOCK 1, 19TH AVENUE, BARANGAY SAN ROQUE, QUEZON CITY, REGISTERED IN THE NAME OF SPOUSES DANTE AND COVERED BYTRANSFER BOMBALES ROSARIO CERTIFICATES OF TITLE NUMBERED N-319240 AND N-326322 OF THE REGISTRY OF DEEDS OF QUEZON CITY, CONSISTING AN AGRREGATE AREA OF ONE THOUSAND FORTY TWO SQUARE METERS AND FIFTY SQUARE (1,042.50) AND REPRESENTED BY ITS DECIMETERS ROMANO (PROACTIVE ASSET PRESIDENT SANTOS B.
