ORDINANCE NO. SP- 2234, S-2013

AN ORDINANCE APPROVING THE ANNUAL BUDGET OF THE QUEZON CITY GOVERNMENT FOR CALENDAR YEAR 2014 IN THE AMOUNT OF THIRTEEN BILLION FOUR HUNDRED SEVENTY SIX MILLION FIFTY SIX THOUSAND SEVEN HUNDRED FIFTY SIX PESOS (PHP13,476,056,756.00) COVERING THE VARIOUS EXPENDITURES FOR THE OPERATION OF THE CITY GOVERNMENT AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE.

WHEREAS, the Local Chief Executive submitted to the Sangguniang Panlungsod, through the Office of the City Council Secretary, the proposed budget of the City Government on October 14, 2013; /

AS *X* *S*

WHEREAS, the Local Government Code provides that "on or before the end of the current fiscal year, the sanggunian concerned shall enact, through an ordinance, the annual budget of the local government unit for the ensuing fiscal year on the basis of the estimates of income and expenditures submitted by the local chief executive;

WHEREAS, the abovementioned proposed budget will cover the various expenditures for the operation of the City Government for the year 2014;




WHEREAS, there is an urgent need to pass this ordinance to support the financial needs and expenditures of the City Government for the year 2014.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. The Annual Budget of the Quezon City Government for Calendar Year 2014 is hereby approved in the amount of Thirteen Billion Four Hundred Seventy Six Million Fifty Six Thousand and Seven Hundred Fifty Six Pesos (Php13,476,056,756.00) covering the various expenditures for the operation of the City Government;

The budget documents consisting of the following are incorporated herein and made integral parts of this Ordinance:


1. Budget Message of the City Mayor, Honorable Herbert M. Bautista;
2. Statement of Receipts;
3. Statement of Receipts and Expenditures;
4. Consolidated Programmed Appropriations and Obligations by Object of Expenditures;
5. Statement of Statutory and Contractual Obligations and Budgetary Requirements;
6. Statement of Fund Operations;
7. Personnel Schedule. /   

SECTION 2. There is hereby appropriated from the General Fund the sum of Thirteen Billion Four Hundred Seventy Six Million Fifty Six Thousand Seven Hundred Fifty Six Pesos (Php13,476,056,756.00) or so much thereof as may be necessary, to be taken from the Estimate of Revenue certified as available for appropriation by the City Treasurer as contained in the budget documents.



SECTION 4. This Ordinance shall take effect immediately upon its approval.


